- · Maintains an up-to-date list of members and their medical particulars or vulnerabilities

EVACUATION / RETURN

- · Variable depending on the community
- · Provides the list of affected members to the person responsible for managing essential services for those affected (food, hygiene, care, mental health, accommodation. adapted transport, etc.)

- · Incident Commander (ECC responsible)
- Participates in RCSOs
- FNIB: Health Role

EVACUATION / RETURN

- Supports FNs in decision-making
- Responsible for expenditure authorizations
- Responsible for expenses and reimbursements to FNs and other organizations
- Provides support to W8banaki on the ground if capacities are exceeded (liaison officer)

· Prevention, detection, and suppression of all forest fires

PRIORITIES IN THE INTENSIVE **PROTECTION ZONE (IPZ)**

- 1- Protection of communities/human lives
- 2- Protection of strategic infrastructure
- 3- Protection of forest resources

IN THE NORTHERN ZONE (NZ)

- Area primarily located north of the 51st parallel, SOPFEU's responsibility is to monitor and assess fires
- Fires are only fought if they threaten communities and strategic infrastructure
